Regarding case M 1333-11

Considering the large volume of material in SKB AB's application (case M 1333-11) to build a repository for irradiated nuclear fuel Milkas requests until 1 June 2012 to submit comments on the need for supplementary information. It is also requested that all consultation bodies and the public be given until 1 June 2012 to submit comments on the need for supplementary information.

The date of 1 June 2012 is requested as it has been granted for other consultation bodies. However, at least until the end of 2013 is preferred as since the application was submitted 16 March 2011 SKB has submitted new translations from Swedish to English and English to Swedish and a list of errata. Added to the information to analyze is the almost 12 hours of video recordings from the OECD Nuclear Energy Agency International Review Team hearing of SKB in Stockholm 12-16 December 2011. What is more, The Swedish Radiation Safety Authority has published new material that needs to be taken into consideration.

In addition, clarification is requested on the deadline set for the Swedish National Council for Nuclear Waste (*Kärnavfallsrådet*) to submit comments on the need for supplementary information.
