COMMENTS ON THE PROCEDURE FOR THE MAIN HEARING

The main hearing with site examination in the fall of 2017 for the application by the Swedish Nuclear Fuel and Waste Management Company (SKB) will take place during five weeks and be carried out at several locations. The application concerns complex activities and the examination is very extensive.

Information is given here about how it is proposed that the main hearing will be carried out. Following is a draft of the court procedure, which the opponents are given an opportunity to comment on. The court intends to finalize the court procedure and send it to the parties in July 2017 in connection with public notification of the main hearing.

Opponents are also given the opportunity to report if they intend to participate in the main hearing. Advance notice is not required in order to participate, but the information requested now facilitates the court's planning.

When the opponents estimate the amount of time required for oral presentation, it is based on the court having received the documents regarding the case, including the opponents' comments. The opponents are therefore asked to consider the following:

- At the main hearing, opponents are given the opportunity to present their views on the application by giving a more general account of the content of the submitted documents. The parties may, regarding technical matters, refer to submitted documents (see Chapter 22, Section 20 of the Environmental Code). The Court will, however, take into account that complex activities are being addressed.
- Long recitation from submitted documents must be avoided.
- Supporting notes, for example in point form, can be an aid.
- Presentations with images, using for example PowerPoint, may be made.

During the main hearing, the possibility of deviating from the court procedure will be very limited (see the rules on lawful absence in Chapter 32, Sections 6 and 8 of the Code of Judicial Procedure). The reason is that deviations lead to a longer and thus less efficient main hearing for all involved. Should a party now request a deviation from the court procedure, concrete reasons must be given.

You are given an opportunity to comment as follows.

1. You are given an opportunity to provide comments to the court on the draft court procedure.
2. You are asked to inform the court:
 - a. if you intend to provide comments at the main hearing and, if so, on what days and during what parts of the court procedure you intend to provide comments
 - b. about how much time you expect you will need for each respective point
 - c. about how many people you expect to participate with in the main hearing, including how many you expect to participate with in Oskarshamn and Östhammar

Information under 2 is not required for short presentations (approximately 5 minutes).

Important information about the possible need for an interpreter

3. You must inform the court if you intend to provide comments *in a language other than Swedish* and in that case during which point in the court procedure.

Information: the main hearing will be held in Swedish. The court will arrange for any interpreters.

When must comments be given?

Your comments must be in writing and submitted to the court no later than **17 May 2017**. *Time extensions cannot be expected*. Comments must include that they are regarding case number M 1333-11.

The Land and Environmental Court readily accepts submissions that are not too extensive via e-mail in PDF format. If a document is sent via e-mail it does not also have to be sent in another manner. Give case number M 1333-11.

Other information

1. The court intends in the public notification in July to provide the opportunity for those wanting to attend site examination of facilities to register their name and personal ID, see the information under the next heading. The public notification will state how to register.
2. The court intends in mid-August to provide opponents the opportunity to:
 - a. inform as to which people intend to participate in the main hearing (*Note: this is optional*)
 - b. notify if an opponent intends to make image presentations (e.g. PowerPoint)
 - c. notify interest for lunch, so that advance restaurant bookings can be made.

ADVANCE REGISTRATION FOR SITE EXAMINATION

Entrance to the central holding storage for spent nuclear fuel Clab in Oskarshamn in connection with the site examination requires advance registration of all participants according to the Swedish Radiation Safety Authority's Regulatory Code on Physical Protection of Nuclear Facilities (SSMFS 2008:12). Participation requires *advance registration with name and personal ID* with SKB no later than Friday 15 September.

For site examination of the Cannister Laboratory in Oskarshamn *advance registration with name and personal ID* with SKB no later than Friday 15 September is required.

For site examination of the Äspö Hard Rock Laboratory *advance registration with name and personal ID* with SKB no later than Friday 15 September is required. The tunnel facility is not wheelchair accessible.

For site examination of the location for the spent nuclear fuel repository *advance registration with name and personal ID* with SKB no later than Friday 15 September is required.
